

KNOWN LIMITATIONS AS OF MAY 15th

The purpose of this document is to list the currently known limitations for release 5.0.0210 in Genium INET External Test 4.

- No clearing-related functionality is available as the early tests are set to Trading only (which corresponds to the standard setup of EXT3 test environment).
- Nasdaq Front-ends have not yet been updated with new API changes on in- and out-bound messages, but can be used for some verification (for example to check if your order has been placed in the order book) but not for any of the upcoming changes.
- GCF market data is not yet available.
- Instrument configuration is partly outstanding for Fixed Income (FI) and Commodities (COM) products, affecting pre-trade transparency, MMT flags and trade reporting. See details below in API impact tables.
- OTC products are not yet available.
- TrayPort (COM) is not yet available.
