### SHAMARAN REPORTS PAYMENT FOR ATRUSH DELIVERIES

ShaMaran Petroleum Corp.** ("ShaMaran" or the "Company") (**TSX VENTURE: SNM**) (**Nasdaq Stockholm: SNM**) reports that TAQA Atrush BV has received USD \$7.9 million on behalf of the Atrush co-venturers from the Kurdistan Regional Government as payment for August 2017 crude oil deliveries to the export market from the Atrush license. These funds will be shared according to the terms of the agreements between the Atrush co-venturers.
