AFRICA OIL CORP. ACQUIRES SHARES OF ECO (ATLANTIC) OIL AND GAS LTD.

November 16, 2017 (AOI-TSX, AOI-Nasdaq Stockholm) ... Africa Oil Corp. ("Africa Oil", "AOC" or the "Company") announced today that it had acquired 29,200,000 common shares of Eco (Atlantic) Oil and Gas Ltd. ("Eco" or the "Company") (TSXV:EOG or AIM:ECO) for CAD\$0.48 per common share. The common shares acquired by Africa Oil, represent approximately 19.77% Eco's issued and outstanding share capital. The common shares were acquired by private arrangement through the facilities of the TSX Venture Exchange on November 15, 2017 for a total consideration of CAD\$14,016,000 (approximately US\$10.9 million).
