NEW HDS APPROVAL FOR PHARMAGEST INTERACTIVE

On 10 December 2013 PHARMAGEST INTERACTIVE was again approved as a Personal Healthcare Data Host by the Minister of Health. This additional approval is an extension of its TELE100T personal healthcare data hosting service, for which PHARMAGEST INTERACTIVE received approval in August 2012.

The new service, called "**TELE100T®- APS (Accès Patient Sécurisé - Secure Patient Access)**" is intended to accommodate applications that are managed and administered by its professional clients in the healthcare sector and especially its pharmacy clients wishing to open a website selling medication online in compliance with the latest regulatory requirements. These applications containing personal healthcare data intended for medical follow-ups will be directly accessible by the patient, thanks to this new approval.
