Features of the Company

Annual Report as of 30 September 2007
UBS (Lux) Key Selection Sicav

UBS (Lux) Key Selection Sicav was incorporated on 9 August 2002 as an open-end investment fund in the legal form of a "Société d'Investissement à Capital Variable" (SICAV) in accordance with Part I of the Luxembourg law relating to undertakings for collective investment enacted on 30 March 1988 and amended to comply with the requirements of the Luxembourg law of 20 December 2002 in February 2004.

The Articles of Association were published in the "Mémoires, Recueil des Sociétés et Associations" (hereinafter called "Mémoires") on 23 August 2002, and deposited at the Commercial and Company Register of the District Court in Luxembourg for inspection. All changes are published with a deposit notice in the "Mémoires". Such amendments become legally binding in respect of all shareholders subsequent to their approval by the general meeting of shareholders.

UBS (Lux) Key Selection Sicav (hereinafter called the "company") offers investors various subfunds ("Umbrella Construction") which invest in accordance with the investment policy described in the sales prospectus. The sales prospectus contains specific details on each subfund.

The company can issue several share classes for each subfund.

So far, the following share classes are available:

- Class "A" shares (= distribution shares) which entitle the shareholder to an annual distribution.
- Class "B" shares (= distribution shares), whereby the general meeting of shareholders, upon the proposal of the Board of Directors and after closing the annual accounts, shall decide whether and to what extent distributions are to be paid out.
- Share class FB corresponds to Class B as described above, but has been established solely as an investment opportunity for UBS funds, UBS AG and its companies and is not available to private investors.

The Board of Directors can also issue the above mentioned classes in other currencies apart from the subfund's currency of account. For this reason, subscriptions and redemptions for these share classes are permitted in a currency other than the subfund's currency of account. In this case, the net asset value and the issue and redemption prices are expressed and published in the currency in which subscriptions and redemptions are carried out. The equity-class currency is indicated in the above table in the 'Share class' column and forms an integral part of the name of these classes.

The entirety of the individual subfunds' net assets forms the total net assets of the company, which at any time correspond to the share capital of the company and consist in fully paid-in and non-par-value shares (the "shares").

At general meetings, the shareholder has the right to one vote per share held, irrespective of the difference in value of shares in the respective subfunds. Shares of a particular subfund carry the right of one vote per share held when voting at meetings affecting this subfund.

The company is a single legal entity. With respect to the shareholders, each subfund is regarded as being separate from the others. The assets of a subfund can only be used to offset the liabilities which the subfund concerned has assumed.

The Board of Directors of the company is empowered at any time to establish new subfunds and/or to liquidate existing ones, as well as to establish different share classes with specific characteristics within these subfunds. The sales prospectus will be updated each time a new subfund or an additional share class is issued.

The company is unlimited with regard to duration and total assets.

The financial year of the company ends on 30 September.

The ordinary general meeting takes place annually on 20 January at 10 o'clock a.m. at the registered office of the company. If 20 January is not a business day in Luxembourg the ordinary general meeting will take place on the next business day.

Only the information contained in the sales prospectus and in one of the documents referred to therein shall be deemed to be valid.

The shares of the subfunds of UBS (Lux) Key Selection Sicav are listed on the Luxembourg Stock Exchange.

The issue and redemption of shares of UBS (Lux) Key Selection Sicav are subject to the regulations prevailing in the country concerned.

The annual and semi-annual reports are available free of charge to shareholders at the registered office of the company and of the Custodian Bank.

No subscription may be accepted on the basis of the financial reports. Subscriptions are accepted only on the basis of the current prospectus accompanied by the latest annual report and the latest semi-annual report if available.

To the Shareholders of

We have audited the accompanying financial statements of UBS (Lux) Key Selection Sicav and of each of its subfunds, which comprise the statement of net assets and the statement of investments in securities and other net assets as at 30 September 2007 and the statement of operations and the statement of changes in net assets for the year then ended, and a summary of significant accounting policies and other explanatory notes to the financial statements.

Board of Directors of the SICAV's responsibility for the financial statements

The Board of Directors of the SICAV is responsible for the preparation and fair presentation of these financial statements in accordance with Luxembourg legal and regulatory requirements relating to the preparation of the financial statements. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

Auditor's responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with International Standards on Auditing as adopted by the "Institut des Réviseurs d'Entreprises". Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the Auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the Auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Board of Directors of the SICAV, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, these financial statements give a true and fair view of the financial position of UBS (Lux) Key Selection Sicav and of each of its subfunds as of 30 September 2007, and of the results of their operations and changes in their net assets for the year then ended in accordance with Luxembourg legal and regulatory requirements relating to the preparation of the financial statements.

Other matters

Supplementary information included in the annual report has been reviewed in the context of our mandate but has not been subject to specific audit procedures carried out in accordance with the standards described above. Consequently, we express no opinion on such information. However, we have no observation to make concerning such information in the context of the financial statements taken as a whole.

Without qualifying our opinion, we draw attention to Note 1 b) to the financial statements relating to the valuation of certain assets. This note explains that, in the absence of a liquid market, these assets were valued at their estimated fair value on the basis of mathematical models or other alternative valuation methods. These percentage of the net assets of each subfund as of 30 September 2007 is disclosed in Note 10.

Report of the Portfolio Manager

During the year under review (1 October 2006 to 30 September 2007) the equity markets delivered a strong overall performance and recovered rapidly from a fall in prices and increased volatility in February and July. There was also a rollercoaster ride on the bond markets until the outbreak of the credit crisis in August which exerted pressure on interest rates that had been rising up until then.

The subfund invests in the major markets and asset classes with a variety of different weightings. In the year under review the overweights in the US and the UK made a positive contribution to performance. The underweight in Japan produced a negative performance contribution. The currency strategy and the investment in the UBS Absolute Return Bond subfund were negatively impacted by the carry trades and the credit crisis respectively. No benchmark exists for this subfund.

Report of the Portfolio Manager

During the year under review (1 October 2006 to 30 September 2007) the equity markets delivered a strong overall performance and recovered rapidly from a fall in prices and increased volatility in February and July. There was also a rollercoaster ride on the bond markets until the outbreak of the credit crisis in August which exerted pressure on interest rates that had been rising up until then.

The subfund invests in the major markets and asset classes with a variety of different weightings. In the year under review the overweights in the US and the UK made a positive contribution to performance. The underweight in Japan produced a negative performance contribution. The currency strategy and the investment in the UBS Absolute Return Bond subfund were negatively impacted by the carry trades and the credit crisis respectively. No benchmark exists for this subfund.

Report of the Portfolio Manager

During the year under review (1 October 2006 to 30 September 2007) the equity markets delivered a strong overall performance and recovered rapidly from a fall in prices and increased volatility in February and July. There was also a rollercoaster ride on the bond markets until the outbreak of the credit crisis in August which exerted pressure on interest rates that had been rising up until then.

The subfund invests in the major markets and asset classes with a variety of different weightings. In the year under review the overweights in the US and the UK made a positive contribution to performance. The underweight in Japan produced a negative performance contribution. The currency strategy and the investment in the UBS Absolute Return Bond subfund were negatively impacted by the carry trades and the credit crisis respectively. No benchmark exists for this subfund.

Report of the Portfolio Manager

During the year under review (1 October 2006 to 30 September 2007) the equity markets delivered a strong overall performance and recovered rapidly from a fall in prices and increased volatility in February and July. There was also a rollercoaster ride on the bond markets until the outbreak of the credit crisis in August which caused interest rates to fall back after their previous rise.

The subfund invests in the major markets and asset classes with a variety of different weightings. In the year under review the overweights in the US and the UK made a positive contribution to performance. The underweight in Japan produced a negative performance contribution. The currency strategy was negatively impacted by the carry trades. No benchmark exists for this subfund.

Report of the Portfolio Manager

During the year under review (1 October 2006 to 30 September 2007) the equity markets delivered a strong overall performance and recovered rapidly from a fall in prices and increased volatility in February and July. There was also a rollercoaster ride on the bond markets until the outbreak of the credit crisis in August which exerted pressure on interest rates that had been rising up until then.

The subfund invests in the major markets and asset classes with a variety of different weightings. In the year under review the overweights in the US and the UK made a positive contribution to performance. The underweight in Japan produced a negative performance contribution. The currency strategy was negatively impacted by the carry trades. No benchmark exists for this subfund.

Report of the Portfolio Manager

During the year under review (1 October 2006 to 30 September 2007) the equity markets delivered a strong overall performance and recovered rapidly from a fall in prices and increased volatility in February and July. There was also a rollercoaster ride on the bond markets until the outbreak of the credit crisis in August which exerted pressure on interest rates that had been rising up until then.

The subfund invests in the major markets and asset classes with a variety of different weightings. In the year under review the overweights in the US and the UK made a positive contribution to performance. The underweight in Japan produced a negative performance contribution. The currency strategy was negatively impacted by the carry trades. No benchmark exists for this subfund.

Report of the Portfolio Manager

Asian ex-Japan markets were very strong during the reporting year (from 1 October 2006 until 30 September 2007) on the back of strong earnings growth and sustained liquidity inflow. China was by far the strongest performer with substantial gains on the MSCI China Index due to strong economics and considerable domestic liquidity. India also performed well despite a steep rise in interest rates. Political uncertainties led to relatively weak performances in the Taiwan and Thai markets.

The subfund slightly underperformed its benchmark [MSCI AC Asia ex-Japan (r)] during the reporting year. The major detractor was an underweight in China and related sectors, but this was mostly offset by an overweight in Korean industrial stocks. The portfolio was overweight to the consumer and industrial sectors and underweight to resources. Relative valuations drove the preference for selective ASEAN (Association of Southeast Asian Nations) markets relative to China and Hong Kong.

Report of the Portfolio Manager

During the year under review (from 1 October 2006 until 30 September 2007), the European bond market lost some ground on the back of rising yields. The yield on the 5-year benchmark rate rose from 3.63% to 4.16%, while the yield on the 10-year government bond rose from 3.71% to 4.33%.

In the year under review, the subfund underperformed its benchmark (the Lehman Euro Aggregate 500 mio+). As a result of the strong economic situation worldwide and particularly in Euroland, we kept the duration, i.e. the portfolio's weighted average residual term to maturity, mostly shorter than that of its benchmark.

Report of the Portfolio Manager

During the year under review (from 1 October 2006 until 30 September 2007), European equity markets showed positive returns, even though they saw a correction in May and July. Euro Countries equities began the month of July with an increasing volatility that continued into mid-August. Strong 2nd quarter earnings fought against credit market uncertainty and concerns about subprime losses for the financial sector. A tightening of liquidity in the financial markets caused the US Federal Reserve to inject a record USD 38 billion, the largest amount of liquidity pumped into the system since the days following 11 September 2001.

In the year under review the subfund underperformed its benchmark, the MSCI EMU (r), due to the overweight in financials, the underweight in materials and underperforming overweight positions in financials such as Irish Life, Aegon, ING and Bank of Ireland. Our largest active positions in the portfolio are France Télécom, Suez and Nokia.

Report of the Portfolio Manager

For the year under review (from 1 October 2006 until 30 September 2007), European equity markets showed positive returns, even though they saw a correction in May and July. European equities began the month of July with an increasing volatility that continued into mid-August. Strong 2nd quarter earnings fought against credit market uncertainty and concerns about subprime losses for the financial sector. A tightening of liquidity in the financial markets caused the US Federal Reserve to inject a record USD 38 billion, the largest amount of liquidity pumped into the system since the days following 11 September 2001.

In the year under review, the subfund underperformed its benchmark, MSCI Europe (r), mainly due to our overweight in financials, our underweight in materials and underperforming overweight positions in Barclays Bank, Wolseley and Aegon. Our largest active positions in the portfolio are Total, Barclays Bank and Prudential.

Report of the Portfolio Manager

In the year under review (from 1 October 2006 until 30 September 2007) equities performed strongly worldwide. In spite of the sharp setbacks at the end of February and from the end of July until the middle of August, the losses were quickly offset. Risk aversion and problems in the US subprime mortgage market triggered this volatility. However, the bond markets were able to benefit from the downturn on the equity markets during these periods.

In the year under review the subfund underperformed its benchmark [UBS Customised Global Securities Market Index (GSMI)]. Market selection, stock selection and currency strategy all made a negative contribution to performance; in the case of currency strategy this was because the fund was invested in anti-carry trades. The strategy of overweighting stocks had a positive impact on performance, particularly the overweight in emerging market equities.

Report of the Portfolio Manager

In the year under review (1 October 2006 to 30 September 2007) equities performed strongly worldwide. In spite of the sharp setbacks at the end of February and from the end of July until the middle of August, the losses were quickly offset. Risk aversion and problems in the US subprime mortgage market triggered this volatility. However, the bond markets were able to benefit from the downturn on the equity markets during these periods.

In the year under review the subfund underperformed its benchmark [UBS Customised Global Securities Market Index (GSMI)]. Market selection, stock selection and currency strategy all made a negative contribution to performance; in the case of currency strategy this was because the fund was invested in anti-carry trades. The strategy of overweighting stocks had a positive impact on performance, particularly the overweight in emerging market equities.

Report of the Portfolio Manager

In the year under review (1 October 2006 to 30 September 2007) equities performed strongly worldwide. In spite of the sharp setbacks at the end of February and from the end of July until the middle of August, the losses were quickly offset. Risk aversion and problems in the US subprime mortgage market triggered this volatility. However, the bond markets were able to benefit from the downturn on the equity markets during these periods.

In the year under review the subfund underperformed its benchmark [UBS Customised Global Securities Market Index (GSMI)]. Market selection, stock selection and currency strategy all made a negative contribution to performance; in the case of currency strategy this was because the fund was invested in anti-carry trades. The strategy of overweighting stocks had a positive impact on performance, particularly the overweight in emerging market equities.

Report of the Portfolio Manager

In the year under review (1 October 2006 to 30 September 2007) equities performed strongly worldwide. In spite of the sharp setbacks at the end of February and from the end of July until the middle of August, the losses were quickly offset. Risk aversion and problems in the US subprime mortgage market triggered this volatility. However, the bond markets were able to benefit from the downturn on the equity markets during these periods.

In the year under review the subfund underperformed its benchmark [UBS Customised Global Securities Market Index (GSMI)]. Market selection, stock selection and currency strategy all made a negative contribution to performance; in the case of currency strategy this was because the fund was invested in anti-carry trades. The strategy of overweighting stocks had a positive impact on performance, particularly the overweight in emerging market equities.

Report of the Portfolio Manager

Global equities performed very well during the reporting period (2 October 2006 to 30 September 2007). Although they suffered falls in late February and late July to mid August – triggered by increased risk aversion and the problems in the US subprime mortgage market – these were subsequently recouped. The bond markets benefited for a time from the equity market losses.

The subfund underperformed its benchmark, UBS Cust. Global Securities Market Europe Index (GSMEI), in the year under review. The strategy of overweighting equities relative to bonds paid off, but market allocation, security selection and currency strategy detracted from performance – the latter because we invested in anti-carry trades. On the other hand, our overweighting of emerging market equities had a positive effect.

Report of the Portfolio Manager

Global equity markets generated a positive return over the year under review (from 1 October 2006 until 30 September 2007). Global economic activity continued its steady expansion, however the pace showed signs of slowing in Europe and Japan. In the third quarter of 2007 concerns about credit quality increased the volatility of financial markets and prompted a sell-off across developed regions.

The subfund underperformed its benchmark, the MSCI World (r), in the year under review. On a sector level we favoured telecommunications, pharmaceuticals and diversified financials. With the exception of telecommunications, these sectors underperformed the benchmark. In addition, sectors where we were underweight, namely materials and capital goods, continued to outperform. We see limited investment opportunities in these sectors.

Report of the Portfolio Manager

During the year under review (from 1 October 2006 until 30 September 2007), the Japanese stock market registered a modest gain overall, having fallen sharply at the end of the period. Sectors benefiting from solid growth in emerging regions such as industrials and materials led the market throughout the period. On the other hand, domestic sectors such as financials and retail lagged behind in the context of a stagnant domestic economy.

In the year under review the subfund underperformed its benchmark, the MSCI Japan (r), as stock selection in materials, technology and industrials impacted performance negatively. We continued to focus on companies with compelling valuations and we took profits in technology and autos and added positions in machinery, transportation and capital goods on valuation grounds.

Report of the Portfolio Manager

By the end of the reporting year (from 1 October 2006 until 30 September 2007) the issues and worries related to the sub-prime mortgage market had had a large impact on US equities. Broad equity markets additionally experienced a downturn in the first half of 2007. The Federal Bank raised and then maintained interest rates, since the consumer needed some stability.

During the reporting year the subfund underperformed its benchmark, the MSCI USA (r). Most of the negative impact came from poor sector allocation, with the subfund underweighted in energy, technology hardware and equipment and overweighted in consumer discretionary. Amongst the top detractors at the stock level were overweights in Wyeth and Masco and an underweight in Exxon. The largest contributors were overweights in Amazon and Johnson Controls and not holding Pfizer.

The net asset value and the issue and redemption price per share of any subfund or of any share class are expressed in the currencies of account of the subfund or share classes concerned and are calculated every business day by dividing the overall net assets of the subfund, into which each share class is to be allocated, by the number of shares in circulation in the respective share class of this subfund.

The percentage of the net asset value, which is attributable to each respective share class of a subfund, is determined by the ratio of the shares in circulation in each share class to the total number of shares in circulation in the subfund, and will change when shares are issued or redeemed. When this happens, the net asset value attributable to the respective share class is increased or reduced by the amount received or paid out.

b) Valuation principles

– Securities, derivatives and other investments listed on a stock exchange are valued at the last available market prices. If the same security, derivatives or other investment is quoted on several stock exchanges, the last available listing on the stock exchange that represents the major market for this security will apply.

In the case of securities, derivatives and other investments where the trade on the stock market is thin but which are traded between securities dealers on a secondary market using usual market price formation methods, the company can use the prices on this secondary market as the basis for their valuation of these securities, derivatives and other investments. Securities, derivatives and other investments that are not listed on a stock exchange, but which are traded on another regulated market which is recognised, open to the public and operating in a due and orderly fashion, are valued at the last available price on this market.

– Securities, derivatives and other investments that are not listed on a stock exchange or traded on another regulated market, and for which no appropriate price can be obtained, are valued by the company in good faith according to other principles of its choosing on the basis of the likely sales prices.

– Derivatives which are not listed on a stock exchange (OTC derivatives) are valued by reference to independent price sources. If only one independent price source is available to value a derivative, then the plausibility of the valuation must be verified by means of calculation models which are recognised by the company taking as basis the market value of the underlying instrument from which the derivative derives.

– Shares/units of other undertakings for collective investment in securities (UCITS) and/or undertakings for collective investment (UCI) will be valued at their last net asset value.

– In the case of money market instruments, the valuation price is gradually adjusted to the redemption price starting from the net acquisition price, while at the same time maintaining the return based on this price. If market conditions change substantially, the valuation principles for the individual investments are adjusted to the new market returns.

– Time and fiduciary deposits are valued at their nominal value plus accrued interest.

– The value of swap transactions is calculated by the swap counterparty on the basis of the net present value of all cash flows, both inflows and outflows. This valuation method is recognised by the company.

The company is authorised to apply other generally recognised and auditable valuation criteria in good faith in order to achieve an appropriate determination of the valuation of the net asset value if, due to extraordinary circumstances, a valuation in accordance with the aforementioned regulations proves to be unfeasible or inaccurate.

These valuation criteria are determined by the Board of Directors with prudence, on the basis of market quotations resulting from transactions or from pricing models, as well as from any other source, which may include broker statements, considered as reliable and appropriate by the Board of Directors to reflect what is believed to be the fair value of those securities at the portfolio's valuation point.

In the event of extraordinary circumstances, additional valuations, which will affect the prices of the shares to be subsequently issued or redeemed, may be carried out within one day.

c) Net realized gain (loss) on sales of securities

The realized gains or losses on the sales of securities are calculated on the basis of the average cost of the securities sold.

d) Valuation of forward foreign exchange contracts

The unrealized gain (loss) of outstanding forward foreign exchange contracts is valued on the basis of the forward exchange rates prevailing at valuation date.

e) Valuation of financial futures contracts

Financial futures contracts are valued based on the latest available published price applicable on the valuation date. Realized gains and losses and the changes in unrealized gains and losses are recorded in the statement of operations. The realized gains and losses are calculated in accordance with the FIFO method, i.e. the first contracts acquired are regarded as the first to be sold.

f) Conversion of foreign currencies

Bank accounts, other net assets and the valuation of the investments in securities held denominated in currencies other than the reference currency of the different subfunds are converted at the mid closing spot rates on the valuation date. Income and expenses denominated in currencies other than the currency of the different subfunds are converted at the mid closing spot rates at payment date. Gain or loss on foreign exchange is included in the statement of operations.

The cost of securities denominated in currencies other than the reference currency of the different subfunds is converted at the mid closing spot rate prevailing on the day of acquisition.

g) Accounting of securities' portfolio transactions

The securities' portfolio transactions are accounted for the bank business day following the transaction dates.

h) Consolidated financial statements

The consolidated financial statements of the company are expressed in EUR. The various items of the consolidated statement of net assets and the consolidated statement of operations as of 30 September 2007 of the company are equal to the sum of the corresponding items in the financial statements of each subfund converted into EUR at the following exchange rates.

i) Income recognition

Dividends, net of withholding taxes, are recognized as income on the date upon which the relevant securities are first listed as "ex-dividend". Interest income is accrued on a daily basis.

*j) Receivable on securities sales,
Payable on securities purchases*

The account "Receivables on securities sales" can also include receivables from foreign currency transactions. The account "Payables on securities purchases" can also include payables from foreign currency transactions.

k) Swaps

The company may enter into interest rate swap contracts, forward rate agreements on interest rates swaptions and credit default swaps, if they are executed with first-class financial institutions that specialize in transactions of this kind.

Changes in unrealized profits and losses are reflected in the statement of operations under the changes in "Unrealized appreciation (depreciation) on Swaps".

Gains or losses on swaps incurred when closed-out or matured are recorded as "Realized gain (loss) on Swaps" in the statement of operations.

l) Securities without fixed maturity date

Securities descriptions ending with "XX" in the "Statement of Investments in Securities and other Net Assets" indicate that these securities have no fixed maturity date.

Note 2 – All-in fee

The company pays a monthly all-in fee (monthly all-in commission) for the various subfunds and/or share classes calculated on the average net asset value of the subfunds and/or share classes indicated in the table below:

Out of the above mentioned monthly all-in fee, the company pays for all the costs incurred in connection with administration, portfolio management and safe-keeping of the company's assets as well as their sale, including:

- annual charges and costs of approvals and supervision of the company in Luxembourg and abroad;
- other charges made by supervisory authorities;
- printing of Articles of Association and prospectuses, the annual and semi-annual reports;
- price publications and the publication of notices to investors;
- fees charged in connection with listing the company and with sales in Luxembourg and abroad;
- commission charges and costs of the custodian bank for safekeeping the company's assets, dealing with payments and other expenses payable in accordance with the fund law dated 20 December 2002;
- fees and other costs for the payment of dividends to shareholders;
- audit fees.

Out of the management commission sales fees are paid to distributors and asset managers of the company.

The custodian bank, administrative agent and company nevertheless all have a claim to be reimbursed the costs for special arrangements that they may make on behalf of shareholders or such costs will be charged direct to the company.

The company will additionally bear all costs of transactions (broker's normal commission, fees, taxes, etc.) connected with administration of the company assets.

The company will also pay all taxes levied on the assets and income of the company, particularly the "taxe d'abonnement".

All costs which can be allocated accurately to individual subfunds and/or individual share classes will be charged to these subfunds. If costs pertain to several or all subfunds, however, these costs will be charged to the subfunds concerned in proportion to their relative net asset values.

In those subfunds whose investment policies allow them to invest in other existing UCIs or UCITS there may be charges at the level of the investment fund as well as of the subfund. With investments in units of funds managed directly or indirectly by the company itself or another company related to it by common management or control, or by a direct or indirect holding of more than 10% of the capital or the voting shares, the subfund may be charged only with a reduced all-in administration commission of no more than 0.25% per year on those investments. The company may, moreover, not charge the subfund making the investment with any of the related target fund's issuing or redemption commissions.

If, in accordance with the above paragraph, the company invests in a related fund that charges a lower all-in administration commission than that charged by the subfund making the investment, the company may, instead of the aforementioned lower all-in administration commission, charge the volume invested in this target fund with the difference between the all-in administration commission charged by the subfund making the investment on the one hand and the all-in administration commission of the target fund on the other.

The "Retrocessions" position lists reimbursements of the all-in fee paid to the company. Retrocessions are applied to the relevant subfunds as income. The reimbursements are calculated daily based on the various fee rates in order to ensure that the fee rate of the target fund does not exceed the rate of the subfund.

Note 3 – Taxe d'abonnement

In accordance with the law and the regulations currently in force, the company is subject to a subscription tax at the annual rate of 0.05%, payable quarterly and calculated on the basis of the net assets of each subfund at the end of each quarter.

The taxe d'abonnement is waived for that part of the net assets invested in units or shares of other undertakings for collective investment that have already paid the taxe d'abonnement in accordance with the statutory provisions of Luxembourg law.

Note 4 – Securities Lending

The company may also lend portions of its securities portfolio to third parties. In general, lendings may only be effected via recognized clearing houses such as Clearstream International or Euroclear, or through the intermediary of prime financial institutions that specialise in such activities and in the modus specified by them. Such transactions may not be entered into for longer than 30 days, however. If the loan exceeds 50% of the securities portfolio of the corresponding subfund, it may only be effected on condition that termination of the loan contract is possible immediately.

Note 5 – Income distribution

a) Distribution policy

The general meeting of shareholders of the respective subfund shall decide, upon the proposal of the Board of Directors and after closing the annual accounts per subfund, whether and to what extent distributions are to be paid out by each subfund and/or share class. The payment of distributions must not result in the net assets of the company falling below the minimum volume of assets prescribed by law. If a distribution is made, payment will be effected no later than four month after the end of the financial year.

The Board of Directors is authorized to pay interim dividends and to suspend the payment of distributions.

b) UK Distribution policy

The Company has applied certification as a distribution Fund under the United Kingdom corporation tax principles for the following Classes of shares:

*UBS (Lux) Key Selection Sicav – Asian Equities (GBP) A
UBS (Lux) Key Selection Sicav – US Equities (USD) A*

It is intended that all those Classes of shares will distribute at least 85% of the net investment income attributable to such Classes of shares, computed broadly in accordance with the definition of net taxable income under United Kingdom corporation tax principles, so that these Classes of shares of the Company qualify as "distribution" for the purpose of United Kingdom tax legislation.

All other Classes of shares with a distribution policy may pay dividends but will not qualify as "distribution" for the purpose of United Kingdom tax legislation.

In order to ensure appropriate treatment between shareholders who become shareholders at different points in time, an income equalisation amount is calculated so that any distributions to such shareholders correspond to their actual income entitlement.

Note 6 – Soft commission arrangements

During the period from 1st October 2006 until 30 September 2007, no "soft commission arrangements" were entered into on behalf of UBS (Lux) Key Selection Sicav and "soft dollar commissions" amount to nil.

Note 9 – Portfolio Turnover Rate (PTR)

The PTR is considered an indicator of the relevance of the additional costs incurred when buying and selling investments. It shows how many security transactions occurred as a result of voluntary investment shifts in relation to the average net assets. Note 11 – Applicable law, place of performance and authoritative language

The Luxembourg District Court is the place of performance for all legal disputes between the shareholders, the company and the Custodian Bank. Luxembourg law applies. However, in matters concerning the claims of investors from other countries, the company and/or the Custodian Bank can elect to make themselves subject to the jurisdiction of the countries in which the company shares were bought and sold.

The German version of these financial statements is the authoritative version and only this version was audited by the auditors. However, in the case of company shares sold to investors from the other countries in which company shares can be bought and sold, the company and the Custodian Bank may recognize approved translations (i.e. approved by the company and the Custodian Bank) into the languages concerned as binding upon itself.

Note 10 – Liquidity Crisis

Certain subfunds currently own collateralized financial instruments (ABS, MBS, CDO). Owing to the extreme illiquidity of the markets for such instruments, it is difficult to determine a fair market value, in part due to the lack of actual transactions, large spreads when requesting brokers quotes, and unavailability of reliable data sources. These investments are valued in accordance with the Valuation Policies defined by the Board of Directors (See Note 1b).
